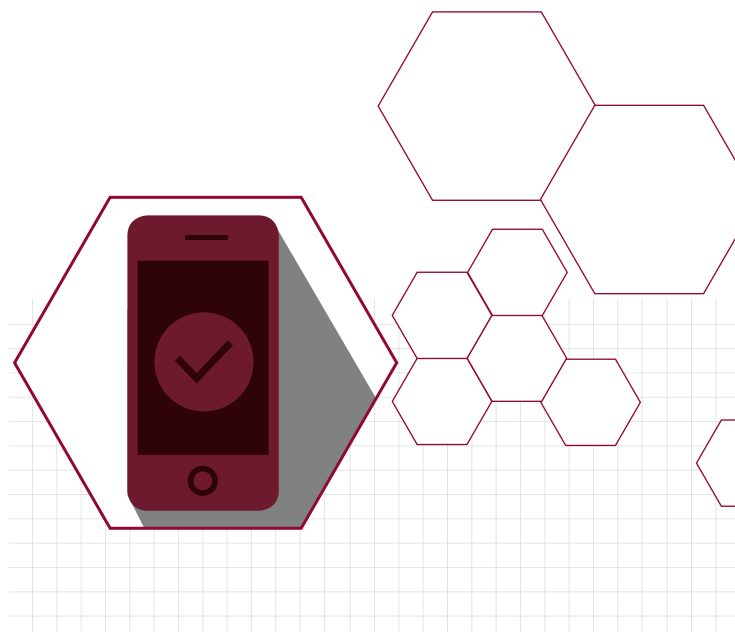

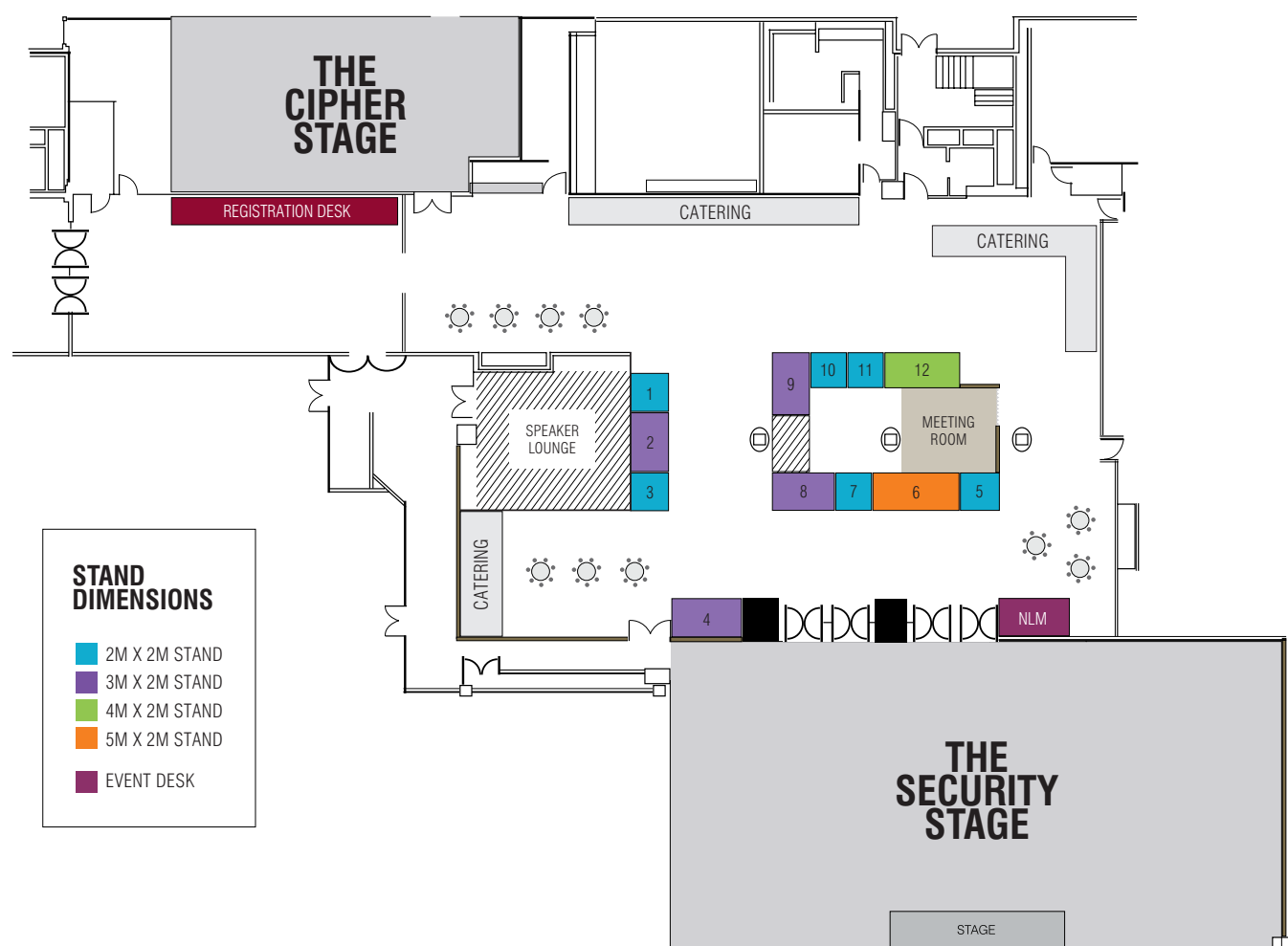

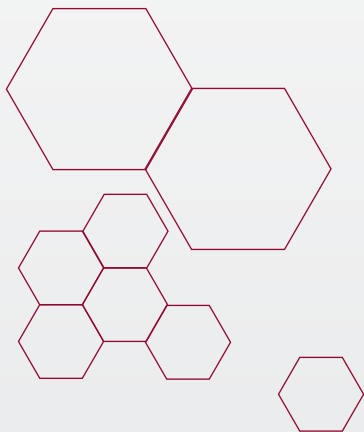

WHAT ARE WE DOING TO KEEP YOU SAFE?
